

Offences of Chain Snatching within the District of Jalgaon disclosed

That in the district of Jalgaon the offences of chain snatching by unidentified youths in the day light were increasing day by day. Offenders committed offence in the solitude places and in the crowded areas of market places by use of motor bikes.

To restrict said offences LCB personals were given duty of surveillance in the city of Jalgaon. Police Naik B.no.2717 Ravindra Bhagwan Patil While on Surveillance at Bhusawal found two offenders in the show room tuning there NS Pulser Bajaj 200 cc bike. Then on obtaining cctv footage and on showing them to complainant and witnesses, thereafter on search of places of residence of the offenders and by obtaining the registration number of motor bike and there upon tracing out the real owner of the motor bikes used in the offence were traced out and upon interrogation of the owners of motor bikes the culprits were arrested from city of Jalgaon and Delhi.

That the said offenders were traced at 8 different places of commission of Crime. That the said offenders were hardened criminals and recidivist and committed crimes in the state of Delhi, Maharashtra etc. They disclosed following offences.
